# **Student Discipline Memo**

Chapter 392-400 WAC

The Office of Superintendent of Public Instruction (OSPI) has adopted permanent revised student discipline regulations which will become effective in their entirety on July 1, 2019. These new regulations are a marked departure from the student discipline structure that has been in place since 1977, and will require changes in student discipline practices, policies, procedures, and

student handbooks prior to the start of the 2019-20 school year. A memo summarizing the changes is available on the PFR website under the "Resources" tab.

# **Washington Court of Appeals**

### **Provisional Nonrenewal**

Frazier v. Quick No. 35586-1-III (4/9/19) (unpublished)

The Washington Court of Appeals held that because Oroville School District followed the statutory process for the nonrenewal of a provisional teacher's contract, the teacher's tort and constitutional claims against the District fail. Ryan Frazier was a provisional teacher with the

Oroville School District. Frazier received a final evaluative grade of Basic and his building principal recommended that Frazier retained. be Nevertheless, the superintendent recommended that Frazier's contract be nonrenewed on the grounds that he failed to create lesson plans, failed to attend staff meetings, and had a cynical and defiant attitude. The Board voted to not renew Frazier's contract. Frazier sued the superintendent individually and the District, alleging various tort claims and seeking a constitutional writ of certiorari. Following partial summary judgment and a bench trial, the trial court dismissed all claims and denied the writ. Frazier appealed. The Court of Appeals held that the District properly followed the process set forth in the provisional nonrenewal statute, and that there were tenable reasons for the nonrenewal decision. As a result, the Court affirmed the trial judge's denial of the writ on the grounds that the District's action was not arbitrary or capricious.
